## **Other Reports:**

PRAB Director's report July 2025

### **a. Grants**

- Staff are submitting for final reimbursement for the Tourist Park Day-Use Playground. A ribbon cutting will be scheduled for early August.

### **b. Project Update**

- The Tourist Park Day-Use Access Road and Parking Area have been designed and bid requests are being reviewed. Construction is expected to start in August, and this project will not affect Hiawatha or GUTS.
- Presque Isle Bandshell - Fundraising for the new Peg Hirvonen Bandshell is underway. \$1,559,722 has been raised so far with a goal of reaching \$2.2 million.

Miron Construction has started construction.

- Cultural Trail/Center: Premeau Construction has been awarded the contract for the Cultural Center, and they have started construction.

c. Marinas:

- Pier 1 at Cinder Pond Marina sustained minor damage in seiche that occurred in late June. The pier has twisted, and it appears the ballast is saturating. Staff will monitor this pier throughout the season and take action if needed. Additionally, the diesel pump has failed and required a "band aid" fix to maintain service. Staff have determined that the pumps must be replaced, and we are working with a vendor to get this done.

d. Lakeview Arena:

- The Olson Arena ice was scheduled to be installed in mid-August. However, a major user group decided to move all their ice to the Berry and the City could not financially justify putting the ice in. Both the Russell and Olson ice will be installed after Labor Day.
- No updates on the potential sale of Lakeview Arena.
- Events at Lakeview Arena:
  - o Past events, KBIC Pow Wow, Cherry Creek Family Dance, Superiorland Ski Swap, and UPW Marquette Mania Wrestling, Juneteenth Celebration, UPCHS Community Resource Fair.
  - o Upcoming events: Vets Fishing Day 8/1-8/2, Ore to Shore 8/8-8/9, Derby Bout 8/23

e. Tourist Park:

- Hiawatha Music Festival is 7/18-7/20, and GUTS Frisbee is 8/2-8/3

h. Presque Isle: The stairs to the breakwater have been replaced in collaboration with the Superior Watershed Partnership.

b. Marina Fiscal Policy

- i. Marina raises rates 10% for first 4 years then 6% after that every year

- ii. 2027 will be the year the marina at the cinder pond will be replaced
- iii. Transient slip fees will follow waterways grant programs. These will increase as well with their rate scale.
- iv. Marina is funded by state 50%
- v. Carole Touchinski made a motion that the user groups be given the opportunity to be informed and give public comment to the PRAB. It is also requested PRAB be given more information from the city on Marina costs and revenue as well as planned improvements (projected estimated annual expenses) before providing a recommendation to the city for the rate increases. Please provide information in accessible format. Amy Maus seconded the motion.
