1.Roll Call

6.a.CSG Analysis of potential property redevelopment:

*When do we apply for tax credit

*MI application process is August to whom credit is awarded

*50-80% of the design process needs to be complete

*4% vs 9% in tax credit

*How long to get architect drawings? About 3 mo.

*Net sponsor investment

*Fund raising is a possibility

*Other traditional resources we can pull from -Federal home loans, Printer project, Residual receipt loans

*Are there grants? Sure

*Zero demolition scenario. Certain structural items need to be preserved.

*Unit sizes for 24,000sq. ft building (1600 sq ft for 2BR, 2000 sq ft for 3BR, 2400 sq ft for 4BR – looks like housing, not apartment sizing)

*Sq. ft. requirement or tax credit

*Prefer the 30 unit proposed.

ii. Pine Ridge: Item 1d - Regarding bad debt, are we being proactive in not letting tenants get in the position of bad debt. Before they sign a lease, we do background checks with previous landlords about their payments. 2e - Interest income is off the reserve.

iii. Lake Superior Village: 5d - Mortgage interests dropping each month. 18b - Health benefits October - November.

It was proposed to have a committee meeting to review the financials. Stark, Schumacher, and Agassi volunteered, but we can only have two, so Agassi stepped down.

d. Approval of checks: Next month registers may be a little complicated due to changing software programs.

e. Cash Positions Statement: Bottom line are the totals. Three months of operating.

f. Pine Ridge Report: Noticed how quickly the waitlist numbers have gone up.

g. Lake Superior Village Report: Moved families into right-sized housing.

h. Housing Choice Voucher Report: Monthly percentage of funds lower to make sure enough money is available for the Black Rock vouchers to be filled. No contract is signed until units pass inspection.

9. New Business:




